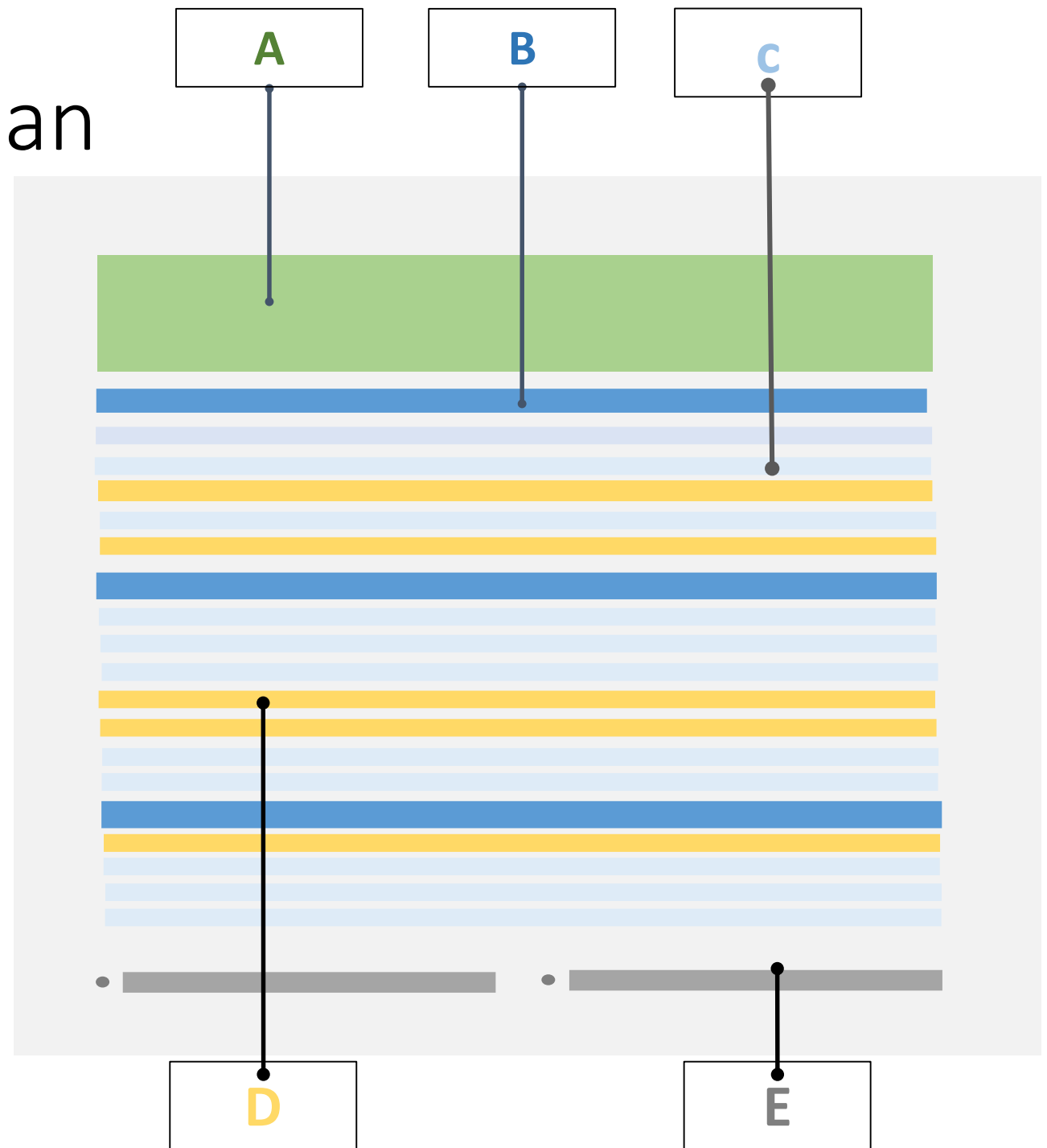


# Elements of a workplan

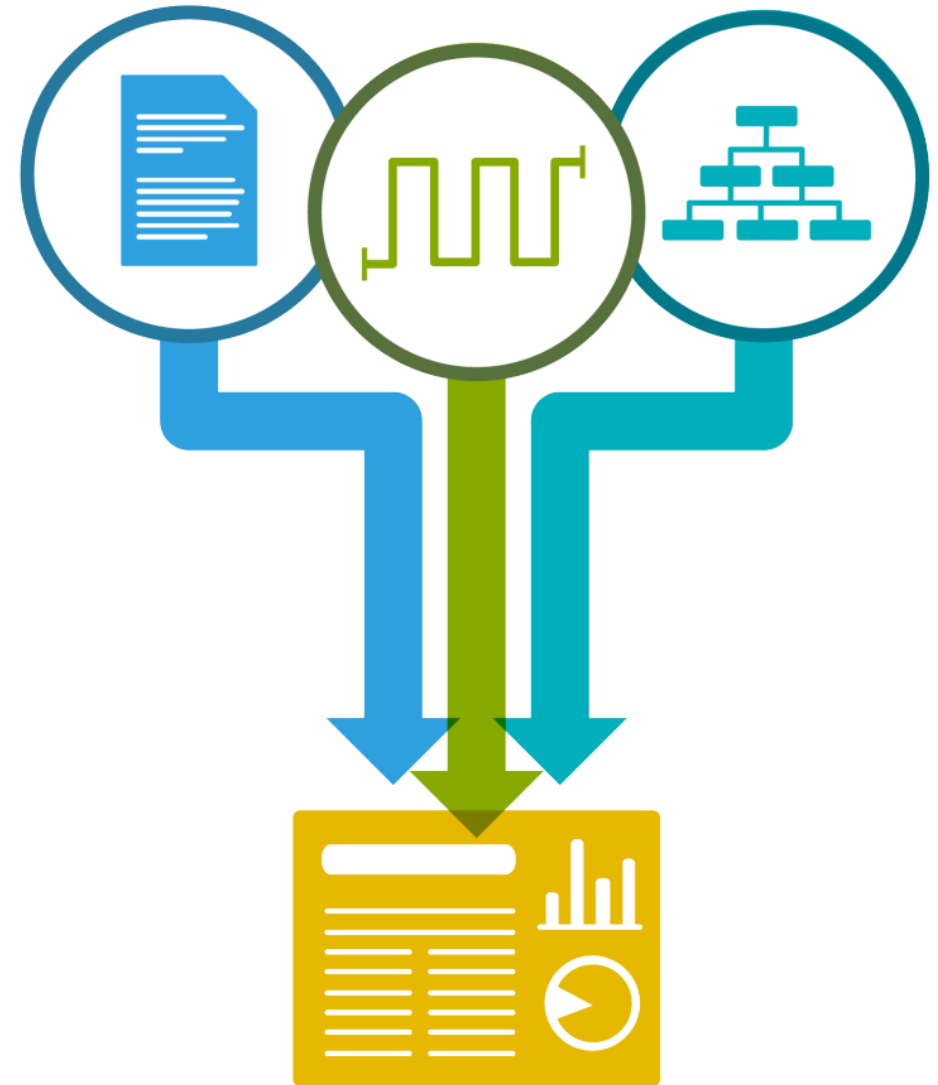
The FWG is gathering inputs for its draft 2<sup>nd</sup> 3-yr workplan. Next, FWG will streamline & prioritize. Here are elements:

- **A. Introduction by FWG members** Recall functions of the LCIPP, cross-cutting considerations, strategic objectives.
- **B. Table organized with headers** LCIPP functions knowledge, capacity for engagement, climate change policies and actions. Table includes activities, results, possible approaches, inputs, possible partners, timeframe.
- **C. Rows with activities** building on experiences from initial two-year workplan.
- **D. Rows with new activities** discussed at FWG5.
- **E. Cross cutting themes, additional partners, additional activity areas** FWG might consider in its draft workplan.



# Design considerations for an impactful workplan

- **Synergies:** How can links and synergies be created with other activities, with the workplans of partners and other constituted bodies under the UNFCCC?
- **Timing:** When would deliverables be especially constructive in the wider UNFCCC process? When are decision moments?
- **Partners:** With whom could activities be undertaken – relevant partner organizations, constituted bodies – to strengthen knowledge, technologies, practices and efforts of local communities and indigenous peoples, and holistic exchange of experience with Parties.
