

LCIPP Activity 5: Develop an outreach/dissemination plan and thematic training materials

Thematic Training Materials

As part of the two-year workplan of the Local Communities and Indigenous Peoples Platform (LCIPP), the Facilitative Working Group (FWG) is tasked with developing an outreach/dissemination plan and thematic training materials. The following list of resources and materials aims to fulfill the latter part of this activity and is meant to accompany the outreach/dissemination plan. The training materials compiled here are sorted under themes that were predetermined by the FWG. The themes include:

- Traditional knowledge, knowledge of indigenous peoples, and local knowledge systems (including the ethical and equitable engagement thereof, in line with activity 4 trainings)
- Indigenous epistemologies (ways of knowing) and ontologies (ways of being)
- Biodiversity and ecosystems
- Indigenous food systems
- Participation and engagement in climate change processes
- Participation of indigenous peoples and local communities in national climate policies - focus on local-level adaptation action and plans
- Funding opportunities for indigenous peoples and local communities related to climate change
- Indigenous governance and management structures

*To date, materials for the themes of biodiversity and ecosystems, indigenous food systems, indigenous governance and management structures, and Indigenous epistemologies (ways of knowing) and ontologies (ways of being) have not been compiled. These themes are not yet included in this document. Further revisions in the future may include adding materials under these themes.

Much of the thematic training material presented here was developed in connection to the activities of the LCIPP initial two-year work plan, especially the training webinars of activity 4. Together, these resources aim to orient Parties and other relevant stakeholders to the unique worldviews and perspectives with which indigenous peoples and local communities approach conservation in general, and climate change specifically. Training materials aim to impart knowledge and skills as shared in the training webinars and other activities. The materials include input from all seven socio-cultural indigenous regions. These materials are intended as additional resources for those looking to educate themselves further on LCIPP-related issues and topics.
