MANDATE

“Recognizes the need to strengthen knowledge, technologies, practices and efforts of local communities and indigenous peoples related to addressing and responding to climate change, and establishes a platform for the exchange of experiences and sharing of best practices on mitigation and adaptation in a holistic and integrated manner”

(Decision 1/CP.21, para135)



3 Functions

Knowledge: Promoting the exchange of experience and best practices of local communities and indigenous peoples in addressing and responding to climate change.

Capacity for Engagement: Building the capacity of local communities and indigenous peoples to enable their engagement in the UNFCCC.

Climate Change Actions and Policies: Facilitating the integration of diverse knowledge systems and practices to facilitate climate action.

LCIPP EVENTS DURING COP26

- **November 2 – COP Presidency dialogue with indigenous peoples**
 - A space for Parties to engage with the experiences and perspectives of indigenous peoples, demonstrating the commitment of the COP President.
- **November 5 – Multi-stakeholder in-session dialogue**
 - Under the function “climate change policies and actions” this workshop will create an open space to exchange good practices and strengthen the engagement of indigenous peoples and local communities in designing and implementing climate policies at all levels.
- **November 6 and 8 – Annual gathering with indigenous knowledge holders**
 - Under the “knowledge” function: featuring the perspectives of 28 indigenous knowledge holders, this gathering will facilitate the exchange of experience among knowledge holders and strengthen Parties’ capacity to engage with indigenous knowledge in the context of addressing and responding to climate change.

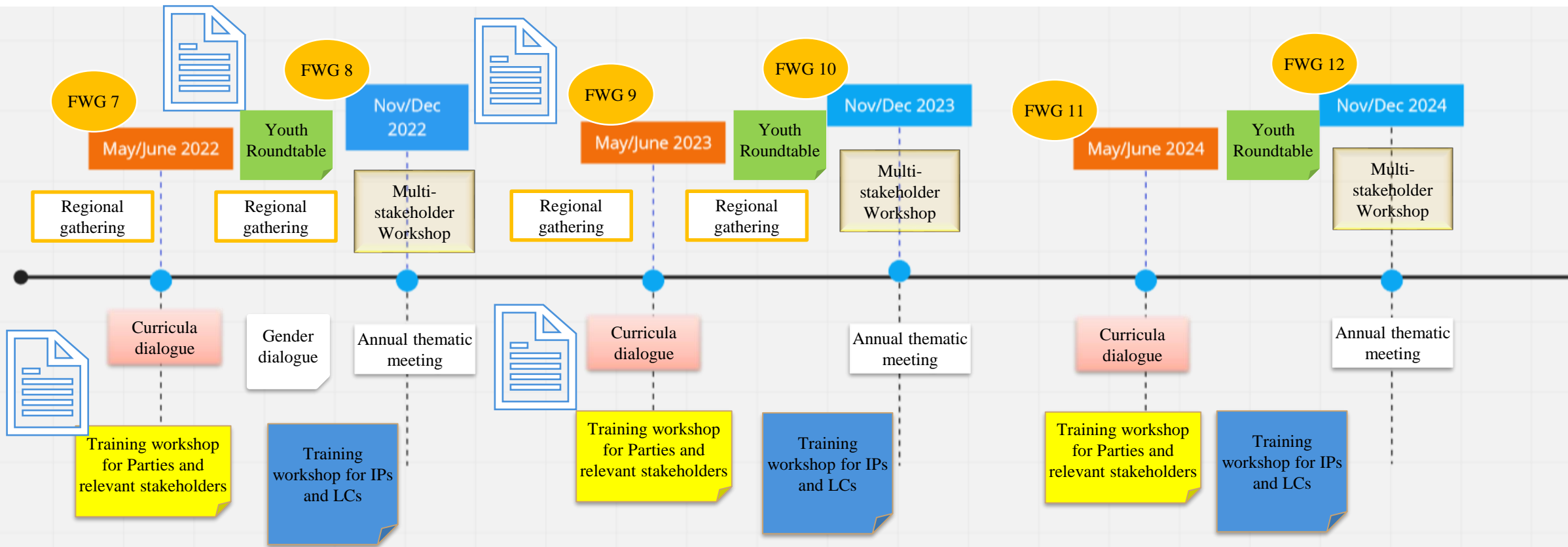

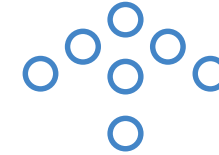
