## **COP 26 decision text related to indigenous peoples and local communities**

| Emphasis   | Excerpt from decision   |

Recommends that the activities under the second three-year workplan facilitate exchange of experience between indigenous peoples and local communities and Parties of <b>approaches to managing all ecosystems</b> , which are key to achieving the objectives of the Convention and the Paris Agreement, in order to enhance national climate policy, including <b>nationally determined contributions</b> ;   |

|  | Market mechanism (PA 6.4): recalls PA preambular text, Supervisory Body engages with Local Communities and Indigenous Peoples Platform; activities to mitigate and trade carbon "Shall undergo local and, where appropriate, subnational stakeholder <b>consultation</b> consistent with applicable domestic arrangements in relation to public participation and local communities and indigenous peoples, as applicable;"   |


