Co-Chairs Note

The Facilitative Working Group (FWG) of the Local Communities and Indigenous Peoples Platform (LCIPP) convened its 6th meeting in October 2021, in conjunction with COP26.¹ FWG members put forward five decision points, during its 6th meeting. This Co-Chairs note summarizes and presents these decision points in accordance with the FWG 6 agenda items.

Summary of decision points from FWG 6

Item 4: Plans for implementing activities under the proposed second three-year workplan

• FWG decided that the members will finalize co-leads list for the activities under the second three-year workplan of the LCIPP intersessionally and initiate preparation of activity concept notes early in 2022;²

Item 5: Discuss draft input paper to the global stocktake

• FWG invited the secretariat to support the FWG in preparing a draft outline and report for submission by February 2022 as input to the first technical dialogue of the global stocktake of the Paris Agreement.

Item 7: Any other matters

- Draft FWG modalities for working
 - FWG invited the secretariat to prepare a draft of working modalities drawing on good practice from other UNFCCC constituted bodies and propose to the FWG members for the FWG intersessionally.
- Submission of resources via the LCIPP web portal
 FWG decided to have a standing agenda item in future meetings for the LCIPP web portal, during which portion of the agenda the FWG would receive updates on new materials added and can review any issues related to knowledge safeguards.

Item 8: Closing

• Date of the next meeting (FWG 7)

FWG decided to convene its 7th meeting between 1 and 3 of June 2022.

Background

The Conference of the Parties, at its twenty-fourth session, established the FWG to further operationalize the LCIPP and facilitate the implementation of the platform's three functions: to

facilitate exchange of experiences and good practices, build capacity for engagement, and weave together diverse ways of knowing to inform climate change policies and actions.

The FWG put forward the decision points summarized in this document on the basis of the group's consensus, per decision 2/CP.24.³

Next steps

- FWG members to volunteer to co-lead one or more activities of the LCIPP second three-year workplan.⁴ The table in the annex provides a list of the nine activities of the LCIPP workplan for the period 2022 – 2024 (updated as of 13 January).
- 2. The FWG invited the secretariat to support the FWG in preparing draft input to the global stocktake.
- FWG invited the secretariat to prepare a draft of working modalities drawing on standard practice from other UNFCCC constituted bodies and propose to the FWG members for the FWG intersessionally.
