#### **Co-chair's Note summarizing Decision Points**

Version 16 June 2022

# 7<sup>th</sup> Meeting of the Facilitative Working Group (01 – 03 June 2022)

FWG agreed by consensus on the following matters at its seventh meeting:

## **Item 2: Organizational matters**

- The new FWG member cohort (list of members in Annex I) was instated
- The new FWG membership elected its new co-chairs and vice-chairs (as noted below). The new FWG co-chairs assumed facilitation of FWG 7
  - Co-Chairs: Mr. Onel Masardule (UN indigenous sociocultural region: Central and South America and the Caribbean); Ms. Natasha Banda Museba (Zambia)
  - Vice-Chairs: Ms. Gunn-Britt Retter (UN indigenous sociocultural region: The Arctic);
     Ms. Tiana Carter (New Zealand)
- FWG adopted the agenda for FWG 7

## Item 3: Global Stocktake update, FWG inputs, and overview of the process

- FWG decided to update its input to the synthesis report to the GST later in 2022, or early 2023 to include additional practices and knowledge of indigenous peoples and local knowledge systems; and
- FWG agreed to extend an invitation to the IPCC to an informal dialogue with the FWG, if possible, prior to FWG 8, to explore engagement in the next IPCC assessment cycle.

# Item 4: Retrospective: Outcomes and impact of the LCIPP initial two-year Work Plan

- FWG acknowledged and reflected on the outcomes and impact of the LCIPP initial twoyear work plan;
- Based on insights and lessons learned, including during the COVID 19 pandemic, FWG agreed, to the extent possible, to facilitate virtual component in future meetings; and
- FWG agreed to engage with the pertinent persons such as knowledge holders, as well as
  the FWG members in intersessional and sessional efforts leading to the implementation
  of the LCIPP work plan.

## Item 5: The second Three-Year Work Plan of the LCIPP (2022 – 2024) (closed session)

- FWG familiarized itself with the second three-year work plan of the LCIPP and its activities.
- The FWG members agreed on co-leading and/or contributing to activities captured in a table of activities (Annex II)
- FWG requested the secretariat to prepare a brief annual progress report on the implementation of the second three-year work plan of the LCIPP
- FWG members agreed that the new co-leads for activities (as indicated in annex II) will review the respective activity concept note(s) intersessionally (suggested within 2 weeks after the conclusion of SB 56, June 2022) and provide any suggestions they may have in order to finalize all the activity concept notes

# Item 6: LCIPP web portal

- FWG considered resource submissions to the LCIPP web portal as of 31 May 2022 and agreed to continue the process for resource submission and compliance check.
- FWG requested Secretariat to scale up efforts towards ensuring accessibility of the
  information on the web portal by exploring modalities to informally translate materials,
  as appropriate and subject to the availability of unearmarked supplementary resources,
  into UN languages. The FWG recalled in its report for FWG 5:
  - The FWG agreed to request the secretariat to explore how interpretation and translation services could be made available in relation to future work under the LCIPP subject to the availability of unearmarked supplementary resources. Such interpretation and translation might include:
    - (a) Interpretation at FWG meetings, as has been the practice at past FWG meetings on account of its unique membership and functions, to further enhance the engagement and contributions of indigenous peoples and local communities under the LCIPP;
    - (b) The translation of deliverables under the draft second three-year workplan, as appropriate.

# Item 7: Enhancing the coherence of the actions of the Local Communities and Indigenous Peoples Platform

• FWG members volunteered as the focal points and alternate focal points to represent the FWG to bodies under the Convention, as appropriate, captured in a table (Annex III)

#### **Item 8: Any other matters**

- FWG decided to use its working modalities to carry out work plan activities for at least 2 years, with a possibility of being reviewed, as appropriate, in 2024
- FWG took note of a suggestion to organize a dedicated pavilion at COP27 to carry out LCIPP work plan activities, and requested the secretariat to explore options, as appropriate.

## Item 9. Closing

The FWG decided to consider convening its 8th meeting between 01 - 04 November 2022, in conjunction with COP27 as mandated in 2/CP.24.
