Housekeeping announcements and interpretation

Prior to the official opening of FWG 9, the secretariat will share housekeeping announcements for the smooth conduct of the proceedings, including the daily schedule, protocol reminders,¹ and logistical information. Additionally, information regarding interpretation services will be provided to facilitate active involvement of all FWG members and to enable contributions from FWG 9 participants when the Co-Chairs open the floor.

1. Opening of the meeting

1.1. Indigenous invocation

A representative of Indigenous Peoples will open the 9th meeting of the Facilitative Working Group (FWG) with an invocation to help orient participants with each other and with the space. The Indigenous Peoples organizations constituency focal points are invited to facilitate the nomination of an Indigenous Peoples' representative to conduct the opening invocation.

1.2. Opening remarks

The 9th meeting of the FWG will officially commence with opening remarks from the Executive Secretary of the United Nations Framework Convention on Climate Change, the Chair of the Subsidiary Body for Scientific and Technological Advice (TBC), and a representative from indigenous peoples organizations.

2. Organizational matters

2.1. Election of new Co-Chairs and Vice Co-Chairs

At its 24th session, the COP decided that the FWG will annually elect two Co-Chairs and two Vice Co-Chairs, each serving a one-year term. It was further determined that one Co-Chair and one Vice Co-Chair should be elected from Party representatives, while the other Co-Chair and Vice Co-Chair should be elected from representatives of indigenous peoples organizations within the FWG membership. Under this agenda item, FWG members are invited to elect FWG new Co-Chairs and Vice Co-Chairs, considering both regional geographic and gender balance.

Action: FWG elects its new Co-Chairs and Vice Co-Chairs.

2.2. Notification of any changes to the membership

The secretariat will announce any relevant changes to FWG membership that have taken place since FWG 8 held in October 2022.

2.3. Adoption of the agenda

The proposed provisional agenda will have been made available by the Co-Chairs of the FWG to the members in advance of the meeting.

Action: FWG considers and adopts the provisional agenda as is, or with revisions agreed upon by consensus.²

3. Progress made on FWG 8 decisions related to the GGA and GST

During its 8th meeting, the FWG decided to further shape the global approach to climate action through their participation and input to the Global Goal on Adaptation and the Global Stocktake process.

3.1. Global Goal on Adaptation

During its third session, the Conference of the Parties (COP), serving as the meeting of the Parties to the Paris Agreement, decided to establish and launch a two-year Glasgow–Sharm el-Sheikh work programme on the global goal on adaptation (GGA). The second three-year workplan of the LCIPP calls for collaboration on scoping document(s) for the contribution of Indigenous Peoples' and local communities' perspectives to considerations on the global goal on adaptation.

The 5th workshop under the GGA work programme took place in March 2023 and focused on "changes in mindsets and world views towards transformation in adaptation, with the inclusion of Indigenous Peoples' wisdom, values and knowledge and consideration of cross-cutting issues."³ Several Indigenous knowledge holders participated in the workshop, including FWG members in their individual expert capacity.

Indigenous knowledge holders highlighted Indigenous approach to nature, treating it not merely as a resource but as kin and an integral part of one's identity. They underscored that nurturing a healthy and regenerative environment is the most transformative climate adaptation action. Advocating for a paradigm shift from exploitation to symbiosis, they highlighted the importance of interconnectedness, referencing Chief Seattle's quote on the web of life.

"Humankind has not woven the web of life. We are but one thread within it. Whatever we do to the web, we do to ourselves. All things are bound together. All things connect."

- Chief Seattle, Suquamish and Duwamish leader

Party representatives also shared practices and measures that recognize the importance of the knowledge and values of indigenous peoples and local communities. They provided examples such as Ecuador's constitutional recognition of nature's rights, the Maldives' restoration of coastal zones through natural coastal nourishment reinforcement, and the implementation of indigenous fire management practices in Australia.

3.2. Global Stocktake Process

The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA) established a technical dialogue as part of the first global stocktake of collective progress towards achieving its purpose and long-term goals of the Paris Agreement. CMA invited relevant constituted bodies to prepare information in their areas of expertise for the technical assessment,⁴ with the assistance of the secretariat. FWG submitted a synthesis report as its input to taking stock of collective progress towards achieving the purpose of the Paris Agreement and its long-term goals.

At its 8th meeting, the FWG decided to update its contribution to the technical dialogues of the global stocktake. It encouraged its members, acting as regional representatives, to gather information for updating the FWG synthesis report. The updated synthesis report can be found in the FWG 9 background document FWG/2023/9/4.

Actions:

- *FWG will discuss ways to advance and enhance the contributions and participation of local communities and Indigenous Peoples in relation to Glasgow-Sharm el-Sheikh work programme on the global goal on adaptation,⁵ and the global stocktake process.⁶*
- *In small group discussions, the FWG will invite contributors to actively participate and respond to the following questions:*
 - **Global Goal on Adaptation**
 - How can the formulation and pursuit of the GGA engage the knowledge and values of local communities and Indigenous Peoples in a manner that respects and promotes rights-based approach?
 - Could you share examples and views from your region that can contribute to the GGA?
 - **Global Stocktake Process**
 - How can the Global Stocktake process engage the knowledge and values of local communities and Indigenous Peoples in a manner that respects and promotes rights-based approach?
 - Could you share examples of climate impacts in your region? Could you also share actions, views, and knowledge systems related to addressing and responding to climate mitigation, adaptation, and loss and damage associated with climate impacts?

4. FWG retreat 2023

During its 8th meeting, the FWG decided to hold an in-person retreat in early 2023 to discuss ways to enhance planning, accountability, and implementation of the second three-year workplan of the LCIPP.

4.1. Revisiting the discussions and agreements from the FWG retreat in January 2023

From 24 to 26 January 2023, the FWG members convened for an in-person retreat in Bonn. The meeting focused on various topics, including in-depth discussions on their ways of working, vision, and plans for all the activities under the current workplan.

4.2. FWG vision

As part of the outcomes from this retreat, the group put forward vision elements. These elements will help guide the group's collective effort to enhance the contributions and participation of indigenous peoples and local communities in the UNFCCC process. For more detailed information about the vision elements, please refer to the FWG 9 background document FWG/2023/9/3.

4.3. FWG working modalities

FWG also reviewed and updated the set of working modalities that the group has agreed upon on a no-objection basis. Please refer to FWG 9 background document FWG/2023/9/5 for more details about these working modalities.

FWG does not have its own rules of procedure of its own. Therefore, the draft COP rules of procedure⁷ applies to the FWG of the LCIPP in accordance with decisions 2/CP.23 and 2/CP.24, as well as any other relevant decisions of the COP.

Actions:

- *FWG will review the vision elements agreed upon during its retreat in January 2023*
- *FWG will adopt decisions based on the agreements made during the FWG retreat*

5. Enhancing the contributions and participation of local communities and Indigenous Peoples at the regional level

5.1. Updates on the plans for all regional gatherings in 2023

The second three-year workplan of the LCIPP calls for at least two regional/biregional gatherings in 2022 and 2023, organized for and in a different UN Indigenous sociocultural region or UN region, with the direct involvement of elders, practitioners, knowledge holders, women and youth from each region in the planning and implementation. The first LCIPP biregional gathering took place in Chad in 2022. Preparatory works are underway for three regional/biregional gatherings to take place in 2023.

5.2. Regional inputs to the updated FWG synthesis report as input to the GST process

At its 8th meeting, the FWG decided to update its contribution to the GST process. The Activity Co-leads have developed outreach communications in English, Spanish, and Russian languages to support members in their roles as regional representatives, thereby enhancing regional input for the update of the synthesis report. The full outreach communication can be found in the FWG 9 background document FWG/2023/9/6.

UN indigenous sociocultural regions of the Arctic and the Pacific, and UN regional group Eastern Europe have submitted regional inputs, please refer to FWG 9 background document FWG/2023/9/4 for more details.

Actions:

- *FWG will exchange views on the content, design and the processes to nominate knowledge holders for the regional gatherings.*
- *FWG will discuss how best to gather regional inputs to the GST process.*
- *In small group discussions, the FWG will invite LCIPP contributors to share their views on ensuring wide accessibility and engagement of knowledge holders in the upcoming LCIPP regional gatherings, while considering constraints related to resource availability.*

6. Ways to contribute towards the implementation of the second three-year workplan of the LCIPP (2022-2024)

6.1. LCIPP at SB 58

In accordance with decision 2/CP.24, the FWG's 9th meeting will take place in conjunction with SB 58 from May 31 to June 3. In addition, the FWG with the support of the secretariat will convene two capacity building training workshops during SB58, as part of the LCIPP second three-year workplan. The first workshop will take place from 13:00 to 15:00 CEST on Tuesday, 6

June 2023. It will focus on prioritizing the participation of Indigenous Peoples, local communities, youth, and women in the UNFCCC process, including the LCIPP, to support the implementation of the Paris Agreement. The second workshop will take place on 7 June 2023, from 13:00 to 15:00 CEST. This workshop enhances the capacity of Parties, constituted bodies, and other stakeholders to respectfully engage with local communities and Indigenous Peoples. This workshop will focus on strengthening human-rights-based engagement of Indigenous Peoples and engagement of local communities in national climate policymaking, as well as their participation in relevant bodies and processes under and outside the Convention related to assessing and responding to climate change. Further details about the FWG meeting and LCIPP workshops will be accessible on the LCIPP web portal.⁸

6.2. LCIPP mandated events at COP 28

At the FWG retreat in January 2023, the members reached consensus on the importance of early theme selection for mandated events. This decision aims to facilitate the timely nomination of knowledge holders. As part of this agenda item, the members will discuss and collectively determine the themes and the associated timeline for nominating knowledge holders for relevant mandated LCIPP events, which are scheduled to take place in conjunction with COP 28.

6.2.1. Activity 1: Annual gathering of knowledge holders

LCIPP second three-year workplan calls for annual gathering of knowledge holders in conjunction with the session of the COP, to take place in round-table discussion format, divided into two parts: one for Indigenous Peoples that includes Indigenous youth and persons of different genders, and a focus on intergenerational knowledge-sharing; and one that includes Indigenous Peoples, local communities, constituted bodies under the Convention and scientific bodies focused on integrating diverse knowledge systems.

The LCIPP annual gatherings aim to expand and enhance the inclusion of traditional knowledge, knowledge of Indigenous Peoples, and local knowledge systems in addressing and responding to climate change, consistently with rights-based international safeguards and Indigenous Peoples' cultural protocols.

Actions:

- *Activity co-leads will share lessons learned from the annual gathering in 2022, which will help inform the upcoming gathering of knowledge holders at COP 28.*
- *FWG will revisit the thematic focus of the annual gathering in 2023 as discussed during the FWG retreat in January 2023 (i.e. Transformative Change: Perspectives from Indigenous Peoples).*
- *FWG will discuss and decide on ways to ensure transparency in the selection and nomination of knowledge holders from the different UN Indigenous sociocultural regions.*
- *FWG will discuss and decide specific timeline for the nomination of knowledge holders from the different regions to ensure adequate time for necessary preparations.*

6.2.2. Activity 3: Annual round-table dialogue on indigenous curricula and materials

To promote a greater understanding of Indigenous knowledge and its importance in relation to assessing and responding to climate change, the former cohort of FWG members decided to “continue to identify and disseminate substantive information about development and use of curricula and materials generated by indigenous peoples related to climate change

that highlight indigenous knowledge in formal and informal education systems, including guidelines on ethical and equitable use of such resources, and disseminate the results via the LCIPP web portal”.

Action: FWG will discuss and decide the configuration of the annual curricula roundtable and desired outcomes.

6.2.3. Activity 7: Multi-stakeholder dialogue

LCIPP in-session multi-stakeholder dialogues bring together local communities, Indigenous Peoples, Parties, and other relevant bodies and processes, to advance the participation of local communities and Indigenous Peoples in designing and implementing holistic climate change policies and actions at all levels.

The Technology Executive Committee (TEC) will be invited to intervene and share views on organizing a joint multi-stakeholder dialogue at COP 28 (Activity 7) and other collaborative opportunities under the TEC workplan for 2023–2027.

Actions:

- *Activity co-leads will share lessons learned from the multi-stakeholder dialogue that was convened in conjunction with COP 27.*
- *FWG will revisit the possible thematic focus and the configuration of this year’s LCIPP multi-stakeholder dialogue, as discussed during the FWG retreat (i.e. Indigenous technologies, sciences, and innovations for climate resiliency).*

6.2.4. Activity 8: LCIPP annual youth dialogue

To enhance the engagement of Indigenous youth and youth from local communities in climate policy development and implementation at all levels, the LCIPP second three-year workplan calls for annual youth round tables.

These youth round tables focus on the role of Indigenous youth and youth from local communities, and concrete ways to advance their engagement in designing and implementing climate policies and actions at all levels.

Actions:

- *Activity co-leads will share lessons learned from last year’s dialogue to help inform the 2023 annual youth dialogue.*
- *FWG will revisit the possible thematic focus of the LCIPP annual youth roundtable and agreed on the thematic focus and configuration of the dialogue.*

6.3. Communications

A key component of the LCIPP second three-year workplan is to identify diverse communication channels, in addition to the LCIPP web portal, to facilitate exchange of experiences, values, knowledge systems to address climate change in a holistic way.

6.3.1. LCIPP web portal

COP 24 requested the secretariat, with the support of the FWG, to make the work of the LCIPP widely accessible, including through the development of a dedicated web portal on the UNFCCC website.

6.3.1.1. Submission of resources

At its 6th meeting, the FWG has decided to keep a standing agenda item on the LCIPP web portal. Under this agenda item, the secretariat will provide a brief updated on exchange of experiences and resources via the web portal.

6.3.1.2. Compliance check

FWG developed guidance on rights safeguards and protocols for the LCIPP web portal.⁹ Under this item, the secretariat will share any compliance issues for guidance from the FWG.

6.3.2. Activity 9

This activity is designed to “identify diverse communication channels in addition to the LCIPP web portal as a shared space, to exchange experience and good practices in relation to addressing climate change in a holistic way.”

6.3.2.1. Informal contributors briefing

As part of the mandated deliverables, the FWG with the support of the secretariat will convene informal contributors’ briefings in advance of FWG 9 to explain agenda and opportunities for engagement.

6.3.2.2. Outreach and Dissemination Plan

The second three-year work plan of the LCIPP calls for updating the LCIPP Outreach and Dissemination Plan (ODP) originally developed under the initial two-year work plan. The Secretariat will report on the progress of updating the ODP, including integrating relevant outputs from the FWG retreat held in January 2023.

Actions:

- *FWG will share reflections on the utilization of the portal in general and ways to promote the exchange of experiences and practices through the LCIPP web portal.*
- *FWG will discuss its communication strategy to promote the exchange of experiences and good practices and make the work of the LCIPP widely accessible.*
- *In small group discussions, the FWG will invite the LCIPP contributors to share ideas/inputs/strategies to ensure meaningful engagement of local communities and Indigenous Peoples in the design and implementation of the upcoming LCIPP-mandated events.*

7. FWG review in 2024

The Conference of the Parties (COP) to the UNFCCC at its 26th session decided that the Facilitative Working Group will be reviewed in 2024.

7.1. Call for submissions.

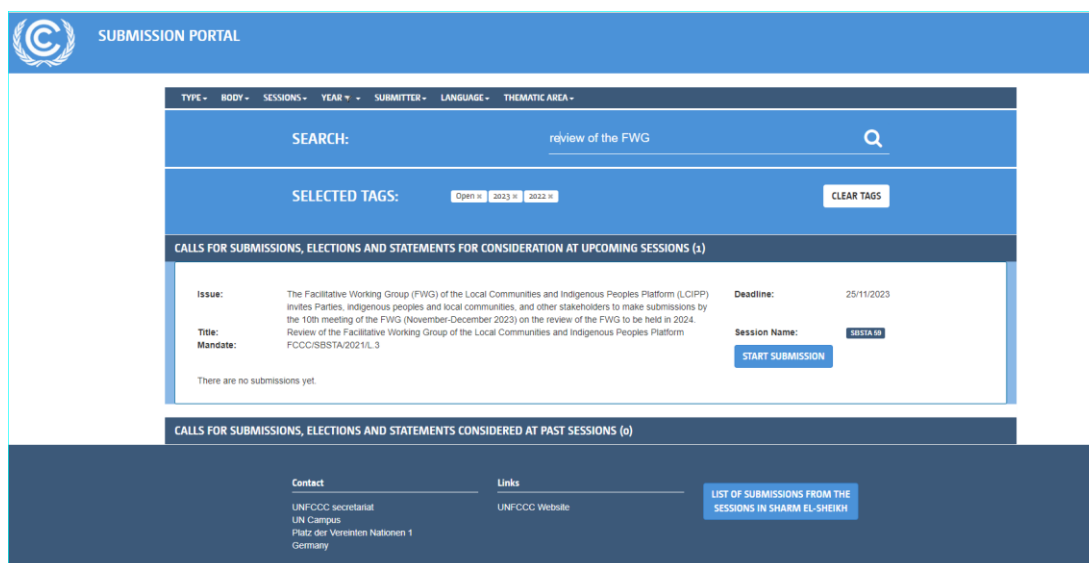

7.2. Developing the draft third three-year workplan of LCIPP (2025-2027)

The COP at its 26th session requested the Facilitative Working Group to report on its outcomes, including a **draft third three-year workplan** of the Local Communities and Indigenous Peoples Platform, and on the activities under the Platform for consideration by the Conference of the Parties at its twenty-ninth session (November 2024) through the Subsidiary Body for Scientific and Technological Advice at its sixtieth session (June 2024);

Actions:

- *FWG will discuss its upcoming review in 2024 and associated call for submissions.*
- *In small group discussions, the FWG will invite LCIPP contributors to share inputs on the FWG review taking place in 2024, as well as inputs/ideas for the third 3-year workplan of the LCIPP.*

8. Enhancing the coherence of the actions of the Local Communities and Indigenous Peoples Platform

The COP at its 24th session encouraged the FWG to collaborate with other bodies under and outside the Convention, as appropriate, aiming at enhancing the coherence of the actions of the LCIPP under the Convention.¹⁰ In this regard, the FWG has a dedicated agenda item at each of its meeting focusing on enhancing the coherence of the actions of the LCIPP.

8.1. Reporting back from members on intersessional engagements

Under this subitem, FWG members will be invited to report back to the group on their intersessional engagements, representing the FWG. The table below provides a brief summary of the engagement and the associated FWG members.

8.4. Collaboration with relevant processes/bodies external to the Convention

- 8.4.1. Green Climate Fund (in relation to the work of the Indigenous Peoples Advisory Group and the implementation of the GCF Indigenous Peoples Policy)
- 8.4.2. Intergovernmental Panel on Climate Change (follow-up actions)
- 8.4.3. Convention on Biological Diversity (Kunming-Montreal Global Biodiversity Framework)

Action:

- FWG will discuss ways to enhance collaboration with relevant bodies and process under and outside the Convention, with the aim to improve the engagement of indigenous values and knowledge, and local knowledge systems into the UNFCCC process.

9. Any other matters

FWG will take up any other matters, pertaining to its role in facilitating the implementation of the three functions of the LCIPP related to knowledge, capacity for engagement, and climate change policies and actions.

Action:

- FWG will take up any other matters that may rise from the discussions.

10. Closing of the meeting

10.1. Dates for FWG 10 (in conjunction with COP 28)

Parties decided that the FWG will meet twice per year in conjunction with the sessions of the subsidiary bodies and the session of the COP, per decision 2/CP.24.

Action:

- *The FWG will decide on the dates of its next meeting, FWG 10, in conjunction with SB59 and COP 28.*

10.2. Decision points for FWG 9

FWG Co-Chairs, with the support of the secretariat, will present draft decision points for FWG 9. These decision points will be shared with the FWG members in advance throughout the course of FWG 9.

Action:

- *FWG will consider and agree or propose changes to the Co-Chairs' summary of decision points from FWG 9 on a no-objections basis.*
