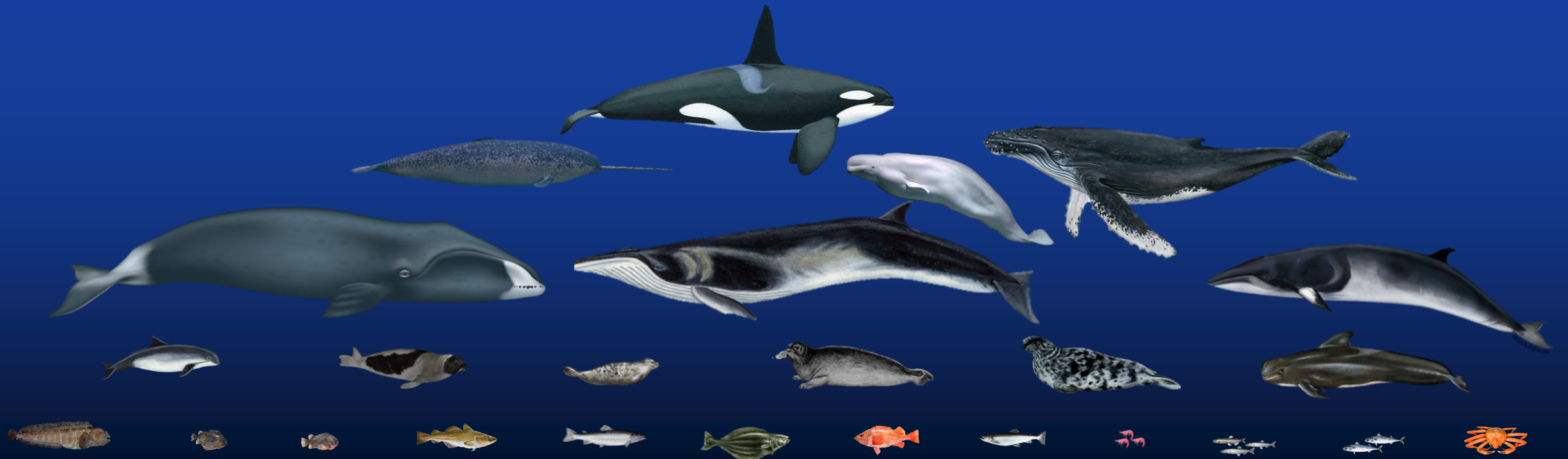

# Kalaallit Nunaat

Which environment is surrounding us? Where are we situated?

Part of the Northern Hemisphere.

Part of the Arctic Ocean.

Part of the Northern Atlantic Ocean.

A country covered in 2,166,000 km<sup>2</sup> area.

Around 10 mill. km<sup>2</sup> ocean.

>44.000 km coast line.

Inhabited by 56.661 people (as of July 1, 2022).

2,670 km from North to South.

1,050 km from West to East.

Country that is rich on living and non-living resources.

Northern most Greenland is dark in almost 4 months during the winter.

Mean temperature +18° C during the summer and -42° C during the winter.

Three time lines (-5 GMT (Pituffik) -2 GMT (Ittoqqortoormiit)).

73 communities (excl. Nuugaatsiaq and Illorsuit) 17 towns and 56 villages.

## International Organizations

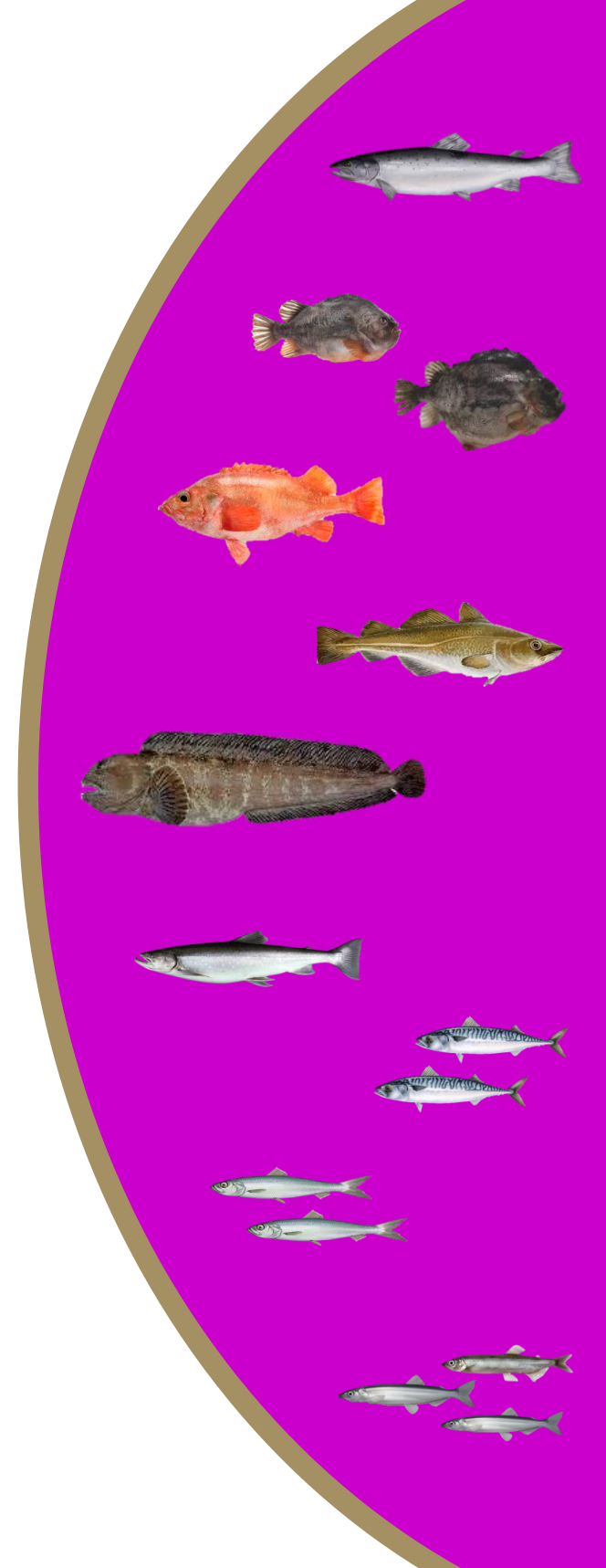
- North Atlantic Salmon Conservation Organization (NASCO) regulate conservation of Atlantic Salmon and quotas for Salmon are allocated every year.
- Northwest Atlantic Fisheries Organization (NAFO) regulate quota for cod and redfish.
- North East Atlantic Fisheries Commission (NEAFC) regulate quotas for redfish, cod, herring, capelin and mackerel.

## Fishery in International Waters

Redfish and cod is regulated by NAFO in 3M and 3N, while redfish, cod, herring, capelin and mackerel is regulated by NEAFC in North East Atlantic, Barents Sea and Russian Sea.

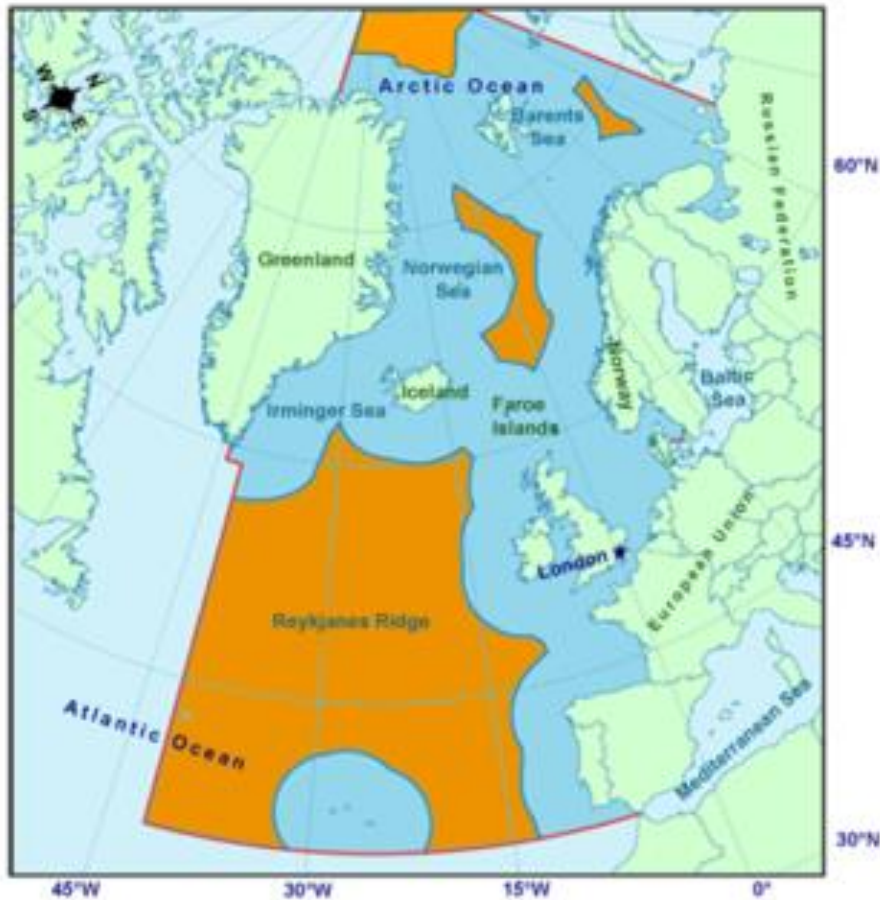

- Greenland income of export from fish and seafood has to increase.

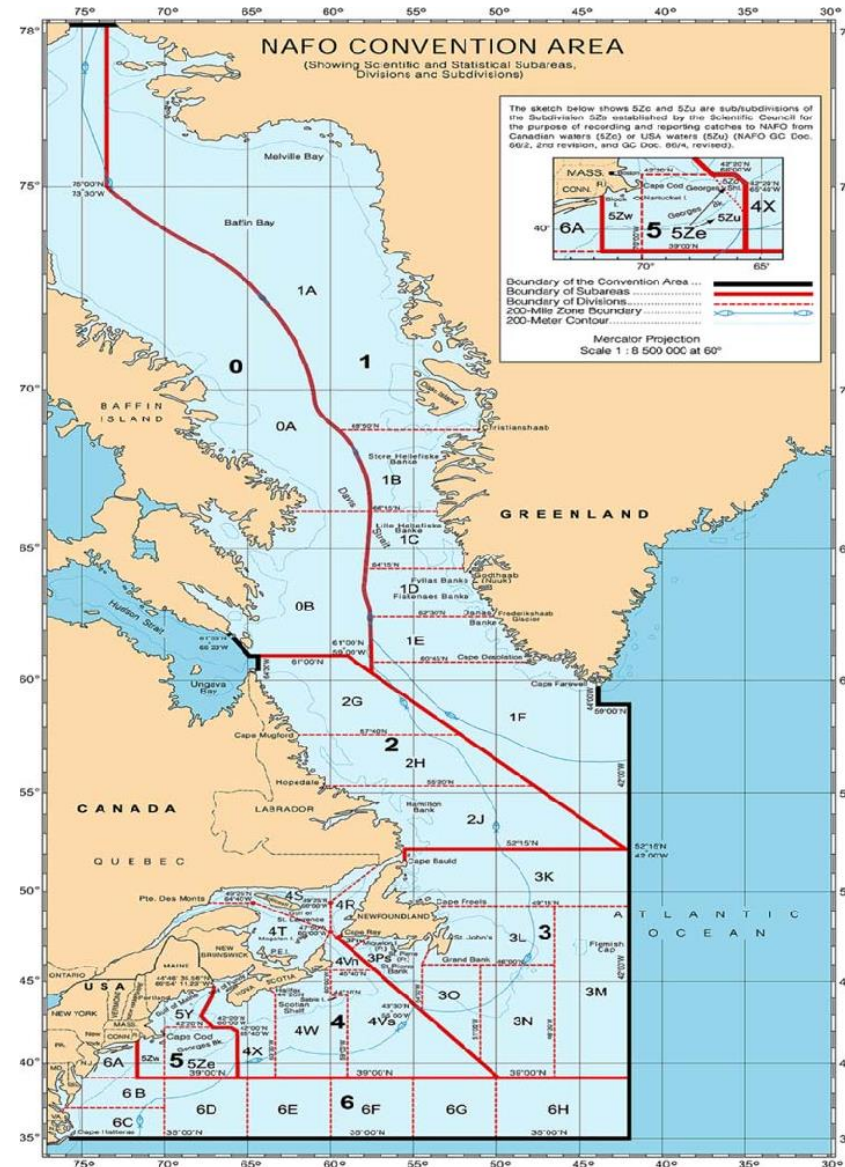
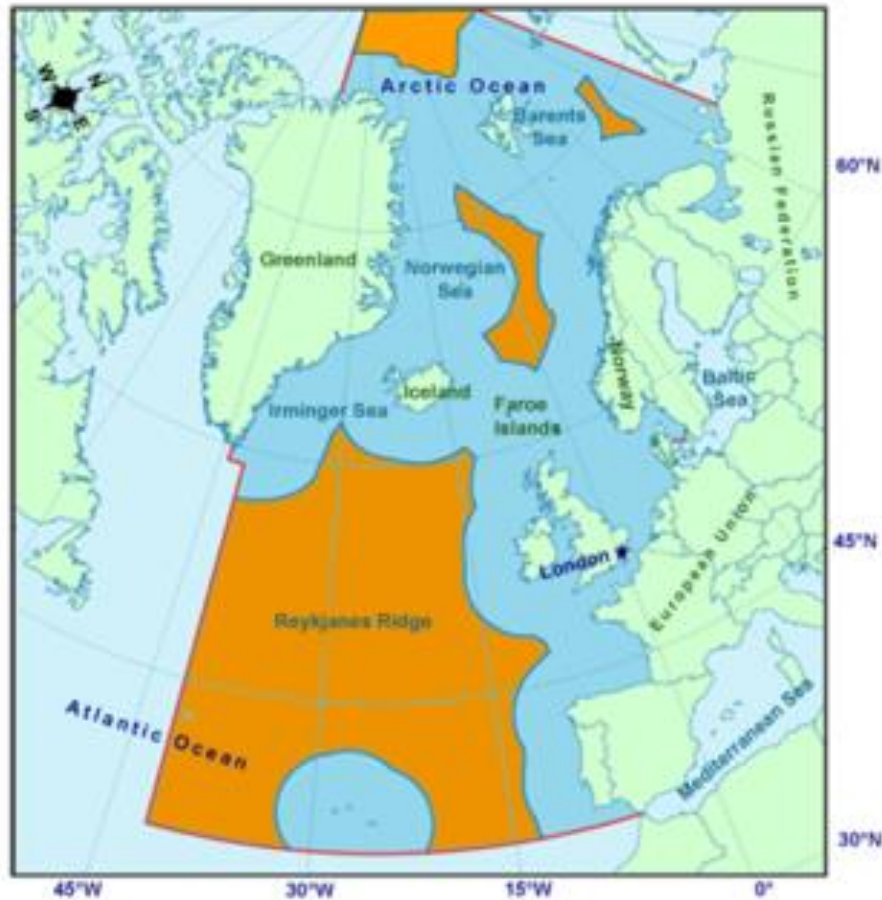

# Consultant Service for Vessel Crew Members

Consultant service for vessel crew members is relatively a new area for KNAPK and there is a plan to hire an consultant in 2023. The consultant will work on counseling the vessel crew members (domestic trawlers and Greenlandic vessel fishing in the international waters) with the rest of the staff in KNAPK secretariat.

Trawling is a unique industry and there is various and broad tasks in this area.

Which rights do crew members have? What options do they have? Why do the crew members pay for the costs of the trawling companies' operation in part fishery? Do the crew members pay retirement savings? What options do crew members have for retirement savings? What requirements do the international vessels have?

- Consultancy.



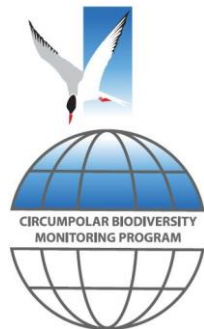

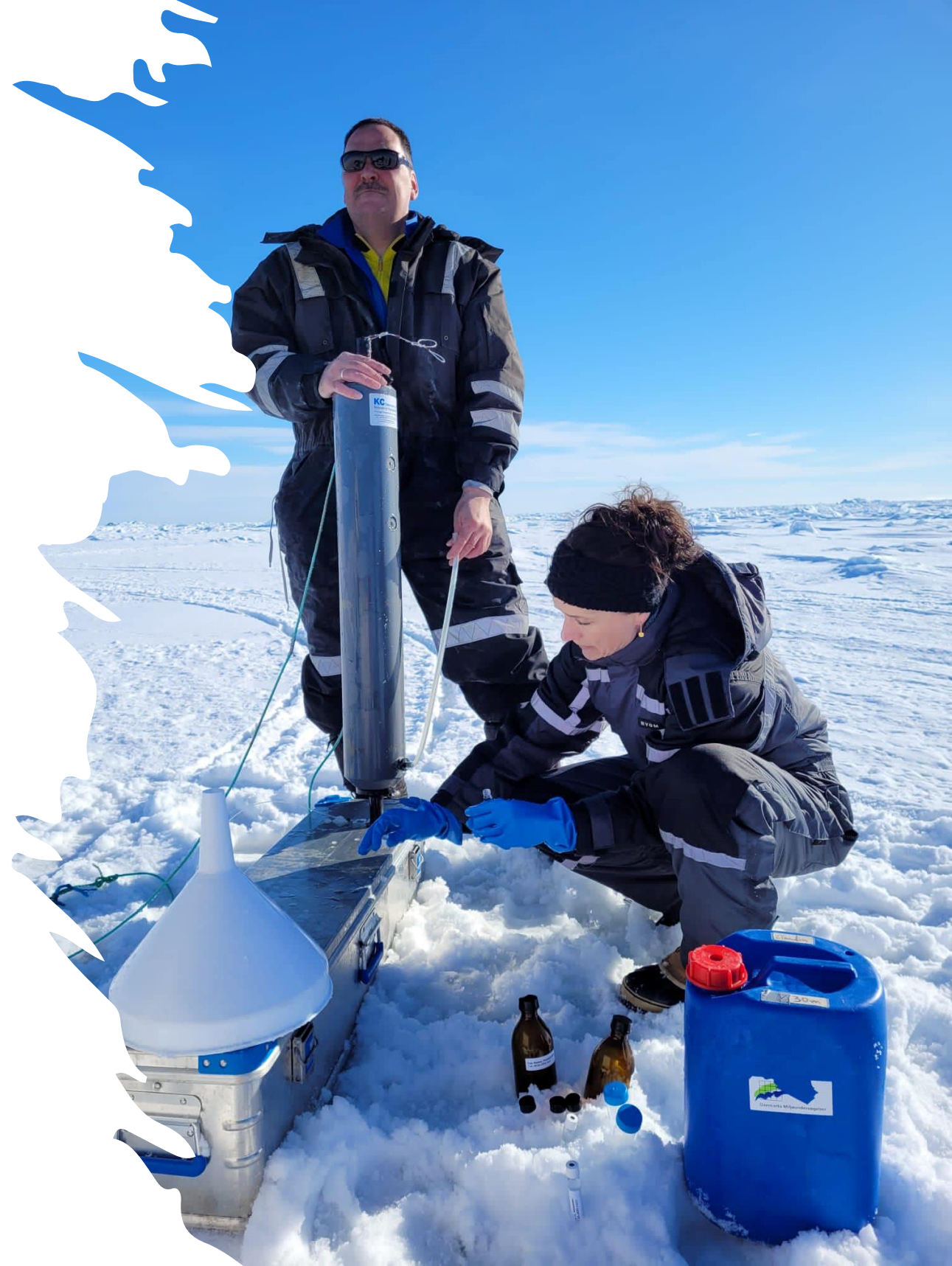
