## a. Election of new Co-Chairs and Vice Co-Chairs

The FWG will elect two co-chairs and two vice co-chairs for a one-year term each. In accordance with decision 2/CP.24, paragraph 9, one co-chair and one vice co-chair will represent Parties, while the other co-chair and vice co-chair will represent Indigenous Peoples.

COP 24 established the FWG of the LCIPP and decided that "the FWG shall comprise 14 representatives, as follows:

- (a) One representative of a Party from each of the five United Nations regional groups;<sup>3</sup>
- (b) One representative of a Party from a small island developing State;
- (c) One representative of a least developed country Party;
- (d) Seven representatives from Indigenous Peoples organizations, one from each of the seven United Nations Indigenous sociocultural regions."

COP 24 further decided that Party representatives shall be appointed by their respective regional groups and constituencies and that the Chair of the SBSTA shall be notified of these appointments. COP 24 also decided that Indigenous Peoples representatives shall be appointed by the Indigenous Peoples, through their focal points, and that the Chair of the SBSTA shall be notified of these appointments.

# c. Adoption of the meeting agenda

<u>Action</u>: FWG adopts the provisional agenda either as presented or with revisions, based on a consensus among its members, per decision 2/CP.24.

# 3. Progress on Decisions from FWG 10

The FWG operates based on consensus, as outlined in decision 2/CP.24, paragraph 15.

During its 10<sup>th</sup> meeting, the FWG made nine decisions.<sup>4</sup> These included adopting a timeline and draft outline for the FWG report and establishing the overall outline and key considerations for the LCIPP workplan for 2025-2027. The group has since completed its report and prepared a draft LCIPP workplan for consideration by the COP at its twenty-ninth session through the SBSTA at its sixtieth session in June 2024. FWG 10 also reaffirmed its commitment to facilitating a deeper understanding and appreciation of the diverse values, worldviews, and knowledge systems of Indigenous Peoples and local knowledge systems in advancing the Global Goal on

Adaptation and contributing to the Global Stocktake process. Additionally, recognizing the important role of LCIPP contributors, the FWG also decided to share summaries of small group discussions from FWG 10. This agenda item will revisit and assess the progress made on these decisions.

## a. FWG report and the Draft LCIPP Workplan for 2025-2027

## <u>Actions:</u>

The FWG notes the changes it has made to the outlines of the FWG report and the draft LCIPP workplan 2025-2027, intersessionally by consensus.

The FWG invites questions and comments from the LCIPP contributors, as time permits.

# b. Advancing the Global Goal on Adaptation and Contributing to the Global Stocktake Process, Ongoing Efforts and Future Directions

The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA) recognized the important role of the values, worldviews, and knowledge of Indigenous Peoples and local knowledge systems, per decisions 1/CMA5 and 2/CMA5.<sup>5</sup> CMA 5 recognized the role of the LCIPP in building and reaffirmed that sustainable and just solutions to the climate crisis must be founded on meaningful and effective social dialogue and participation and called on Parties to meaningfully engage Indigenous Peoples and local communities in their climate policies and action. CMA 5 also recognized the leadership of Indigenous Peoples and local communities as stewards of nature and encouraged ethical and equitable engagement with Indigenous Peoples and local communities and application of traditional knowledge, the knowledge, wisdom, and values of Indigenous Peoples, and local knowledge systems in implementing the United Arab Emirates Framework for Global Climate Resilience.

<u>Action</u>: The FWG will reflect on the outcomes of the GST and GGA from COP 28 (CMA 5) and decide on ways to facilitate the effort to weave the diverse values, worldviews, and knowledge systems of Indigenous Peoples and local knowledge systems into implementing the GST and GGA-related outcomes, including into efforts under the two-year UAE-Belém work programme.

**c.** Sharing of reflections from the small group discussions (Background document: Summary of FWG 10 Small Group Discussions, see document FWG/2024/11/3c)

<u>Action</u>: The FWG shares a summary of the FWG 10 small group discussions and explains how these were considered in the FWG report and the draft LCIPP workplan 2025-2027. The FWG expresses appreciation for the participants' active engagement and invites them to continue participating actively in its work.

# 4. Progress Review and Completion Strategy for the Implementation of the LCIPP Second Three-Year Workplan (2022-2024)

2024 marks the final year of the current LCIPP workplan for 2022-2024. Under this agenda item, the FWG will assess the progress made and discuss SMART plans<sup>6</sup> to complete the remaining activities, fulfilling the relevant mandate and aligning with the FWG vision.

Under this item, there will be dedicated small group discussions to engage the LCIPP contributors in the effort to plan and deliver on the remaining deliverables under the LCIPP workplan for 2022-2024.

a. Activity 1 – Annual Gathering of Knowledge Holders (Background document: information note)

Activity 1 of the LCIPP workplan 2022-2024 is about the organization of annual meetings in conjunction with the sessions of the COP, with the participation of Indigenous Peoples and Indigenous knowledge holders, to expand and enhance the inclusion of traditional knowledge of Indigenous Peoples and local knowledge systems in addressing and responding to climate change, consistent with rights-based international safeguards and cultural protocols. The LCIPP annual gatherings aim to expand and enhance the inclusion of traditional knowledge, knowledge of Indigenous Peoples, and local knowledge systems in addressing and responding to climate change, consistently with rights-based international safeguards and Indigenous Peoples, cultural protocols.

At COP 27 and COP 28 in 2022 and 2023, respectively, the Annual Gathering of Knowledge Holders took place in round-table discussion formats. Both gatherings were divided into two parts. The first part was for Indigenous Peoples, including Indigenous youth and persons of different genders, and focused on intergenerational knowledge-sharing. The second part included local communities, Indigenous Peoples, constituted bodies under the Convention and scientific bodies focused on integrating diverse knowledge systems.

## Actions:

- The A1 co-leads will share lessons from the gathering convened at COP 28.
- The A1 co-leads will share plans for gathering knowledge holders at COP 29.
- The FWG will discuss and decide on the following:
  - The thematic focus of the annual gathering in 2024.
  - Ways to ensure transparency and accountability in selecting and nominating knowledge holders from the different United Nations Indigenous sociocultural regions.
  - The timeline for nominating knowledge holders from the different regions to ensure adequate time for necessary preparations, which will be subject to the availability of resources.

# b. Activity 2 - Bi/Regional gatherings

Activity 2 of the LCIPP workplan 2022-2024 calls for at least two regional or bi-regional gatherings per year in 2022 and 2023, organized for and in a different United Nations Indigenous sociocultural region or United Nations region, with the direct involvement of elders, practitioners, knowledge holders, women and youth from each region in the planning and implementation.

The first-ever LCIPP biregional gathering was held for the Asia and Africa regions. The government of Chad hosted this gathering in October 2022. Subsequently, two regional gatherings were convened in October 2023 for the Arctic and Pacific regions, held in Norway and Australia respectively. All the regional gatherings applied a common framework in designing the sessions, ensuring that the unique attributes from the different regions were showcased.

The bi/regional gatherings provided inclusive and interactive spaces for Indigenous Peoples and local communities to strengthen their understanding of the UNFCCC process and explore

concrete ways to contribute to the collective effort to address climate change. Similarly, the gathering allowed Parties and other relevant entities to learn from Indigenous Peoples and local communities about their reciprocal relationship with nature and ethical ways to engage their values and knowledge systems in designing and implementing climate policies and actions.

FWG members, serving as representatives of Indigenous Peoples organizations from the respective United Nations Indigenous sociocultural regions, have facilitated the nomination of funded participants from Indigenous Peoples within their regions. For transparency and accountability, the informal summary reports of these gatherings include annexes listing the regionally nominated participants.

i. Biregional gathering for the United Nations Indigenous Sociocultural Regions of Asia and Africa (*Background document: informal summary report, see document FWG/2024/11/4b/AA-BRG*)

The Government of Chad hosted the inaugural biregional gathering of the LCIPP for the United Nations Indigenous sociocultural regions of Asia and Africa, which took place in N'Djamena from October 13 to 16, 2022. The lessons learned, both logistically and substantively, provided valuable insights for the organization of subsequent LCIPP regional gatherings.

ii. Regional gathering in the United Nations Indigenous Sociocultural Region of the Arctic (*Background document: informal summary, see document FWG/2024/11/4b/A-RG*)

The Arctic Regional Gathering, hosted by the Norwegian government, was held from 2 to 5 October in the town of Girkonjárga (Kirkenes), Norway. The gathering brought together 89 knowledge holders, Party representatives, UN agency representatives, and other relevant entities. The design and delivery of the Arctic regional gathering were done in collaboration with the Arctic Council.

iii. Regional gathering in the Pacific United Nations Indigenous Sociocultural Region (Background document: informal summary, see document FWG/2024/11/4b/P-RG)

The Pacific Regional Gathering was convened with direct participation from Indigenous Peoples organizations from the Pacific region. It was hosted by the Government of Australia in Port Douglas, Kuku Yalanji Country. Ninety-six (96) participants, including Pacific knowledge holders (over 50 First Nations People), Party delegates, representatives from constituted bodies, NGOs, UN agencies and other stakeholders, attended the gathering. The gathering's program was designed and delivered by FWG with contributions from the Indigenous Peoples Organization of Australia.

# <u>Actions:</u>

- The FWG reviews the informal summary reports from past regional/biregional gatherings and share their reflections.
- Co-leads of Activity 2 related to regional gatherings provide updates on the upcoming gathering/s.
- The FWG discusses and decides the next steps.
- **c.** Activity 3 Indigenous Curricula and materials (Background document: information note, see document FWG/2024/11/4c)

To promote a greater understanding of Indigenous knowledge and its importance in relation to assessing and responding to climate change, the former cohort of FWG members decided to

"continue to identify and disseminate substantive information about development and use of curricula and materials generated by Indigenous Peoples related to climate change that highlight Indigenous knowledge in formal and informal education systems, including guidelines on ethical and equitable use of such resources, and disseminate the results via the LCIPP web portal".

This activity has three deliverables, namely:

- i. Annual round table dialogue.
- ii. Calls for submission and a survey for sharing relevant practices and stories in diverse formats.
- iii. Literature review of the collected materials for dissemination via the LCIPP web portal.

Since 2022, two annual round-table dialogues have been conducted in conjunction with SB 56 (in 2022) and COP 28 (in 2023).

A call for submissions on specific practices and stories related to the development and use of Indigenous curricula and materials in both formal and informal education systems, within the context of climate change, was issued through the UNFCCC submission portal on November 20, 2023. For more information about the submissions and how to respond to this call, please visit the UNFCCC submission portal here and search for the keyword "LCIPP."

Additionally, an outline for the literature review associated with this activity is available in the background note.

## <u>Actions:</u>

- The co-leads of this activity share potential topics for the 2024 roundtable, strategies for mobilizing submissions, and further developments of the draft outline for the literature review.
- The FWG discusses and decides on the following:
  - configuration of the roundtable and desired outcomes in 2024.
  - ways to promote the call for submission.
  - o outline of the literature review.
- d. Activity 4 Annual training workshops for Indigenous Peoples and local communities (Background document: information note, see document FWG/2024/11/4d)

Activity 4 of the LCIPP workplan 2022-2024 calls for training workshops to build the capacities of Indigenous Peoples and local communities to engage in the UNFCCC process and implement the Paris Agreement, as well as strengthening understanding and implementation of rights-based climate policies and actions.

This activity has the following components/deliverables:

- i. Conduct training workshops.
- ii. Evaluate the implementation of the FWG recommendations (in its 2021 report).
- iii. Update the mapping results on existing policies, actions and communications under the Convention and the practices for participation (under and outside the UNFCCC).
- iv. Develop and compile guidance materials on meaningful and respectful participation of Indigenous Peoples and local communities in the UNFCCC process.
- v. Co-organize a dialogue in accordance with the UNFCCC gender action plan.

Since 2022, the FWG has delivered four modules under the training workshops. The FWG also co-organized at COP 27, a joint dialogue in accordance with the UNFCCC gender action plan.

#### <u>Actions:</u>

- The A4 co-leads suggest possible topics for the 5<sup>th</sup> training module and the draft outlines for the two deliverables/outputs under this activity: updating the mapping results and the guidance materials on meaningful and respectful participation in the UNFCCC process.
- The FWG discusses and decides on possible topics for module five, which will be organized in the lead-up to COP 29.
- The FWG discusses and decides on the outlines of the two reports.
- e. Activity 5 Annual training workshops for Parties, constituted bodies, and stakeholders (Background document: information note, see document FWG/2024/11/4e)

Activity 5 of the LCIPP workplan 2022-2024 calls for training workshops led by Indigenous Peoples to build capacity of Parties, constituted bodies and other stakeholders to respectfully engage with local communities and Indigenous peoples, focusing on strengthening human rights-based engagement of Indigenous Peoples and engagement of local communities in national climate policymaking and the work of relevant bodies and processes under and outside the Convention.

This activity has the following components/deliverables:

- i. Conduct annual training workshops.
- ii. Update the technical paper on existing policies, actions and communications related to the engagement of Indigenous Peoples and local communities under the Convention to inform the training workshops.
- iii. Develop guidance materials and recommendations based on the updated technical paper, training workshops and a call for submissions on enhancing rights-based engagement of Indigenous Peoples and engagement of local communities in national climate policymaking.

Thus far, two workshops have been organized in conjunction with SB 56 (2022) and SB 58 (2023).

# Actions:

- The A5 co-leads share the training design being organized in conjunction with SB 60.
- The FWG discusses and decides on draft outlines of the technical paper and guidance materials, including possible strategies to complete the remaining deliverables.
- f. Activity 6 Advance and enhance the contributions and participation of Indigenous Peoples and local communities in relation to the work of constituted bodies under the Convention towards achieving the objectives of the Convention and the Paris Agreement (Background document: information note, see document FWG/2024/11/4f)

Activity 6 of the LCIPP workplan 2022-2024 focuses on actions to advance and enhance the contributions and participation of Indigenous Peoples and local communities in relation to the work of constituted bodies under the Convention, with a view to achieving the objectives of the Convention and the Paris Agreement.

Since 2022, the FWG deployed various strategies to implement this activity. These include assigning members as focal points and alternates for the different constituted bodies, participating in the meetings and mandated events of relevant bodies and work programmes, and serving specialized roles in the bodies' expert and thematic groups. Furthermore, the FWG has facilitated the inclusion of Indigenous experts in the meetings and activities of these bodies.

Notably, Indigenous experts from the United Nations sociocultural regions of Africa, the Arctic, and the Pacific participated in the 20th meeting of the WIM ExCom.

#### <u>Actions:</u>

- The A6 co-leads update the FWG on progress and outline plans for its continued implementation in the second half of 2024.
- The FWG discusses and decides on ways forward.
- **g.** Activity 7 In-session multistakeholder dialogues (Background document: information note, see document FWG/2024/11/4g)

Activity 7 of the LCIPP workplan 2022-2024 is about convening in-session multistakeholder dialogues to advance the participation of Indigenous Peoples and local communities in designing and implementing holistic climate change policies and actions at all levels.

Since 2022, two in-session multistakeholder dialogues have been held in conjunction with COP 27 and COP 28.

#### Actions:

- The A7 co-leads share lessons from the multi-stakeholder dialogue convened in conjunction with COP 28.
- The FWG discusses and decides on the following:
  - Draft A7 report.
  - thematic focus and configuration of multi-stakeholder dialogue @COP 29.
- **h.** Activity 8 Annual youth roundtable discussions (Background document: information note, see document FWG/2024/11/4h)

Activity 8 of the LCIPP workplan 2022-2024 is about hosting annual round tables in collaboration with Indigenous youth and youth from local communities to explore gender-responsive ways and means to strengthen the engagement of youth and the participation of intergenerational knowledge-sharing and continuing/strengthening practices on the ground, as well as to contribute to climate policies and actions at all levels.

To date, two roundtable discussions have been organized in conjunction with COP 27 (2022) and COP 28 (2023).

## Actions:

- The A8 co-leads share lessons from last year's dialogue and suggestions for the 2024 annual youth roundtable.
- The FWG discusses and decides on the following:
  - Possible modalities to further engage Indigenous youth and youth from local communities.
  - The thematic focus of the LCIPP annual youth roundtable @COP 29.
- i. Activity 9 Communications (Background document: revised ODP, see document FWG/2024/11/4i)

Activity 9 of the LCIPP workplan 2022-2024 is dedicated to identifying diverse communication channels beyond the LCIPP web portal to facilitate the exchange of experiences and best practices.

Recognizing that the transmission of Indigenous Peoples' worldviews, values, and knowledge as well as local knowledge systems—goes beyond traditional written communication, the FWG has adopted a variety of modalities for exchanging information, knowledge, and experience. These include small group discussions during meetings, LCIPP regional gatherings, and intersessional informal contributors' briefings. Furthermore, the FWG has incorporated photos and music playlists into its meetings, weaving together diverse values, worldviews, and practices through multiple communication channels and formats.

## LCIPP dedicated web portal

In line with decision 2/CP.24, paragraph 21, the secretariat with the support of the FWG developed a dedicated LCIPP web portal. This web portal was created to make the work of the LCIPP widely accessible. It offers a platform for Indigenous Peoples, local communities, Parties, and other relevant entities to share and promote their efforts to address climate change.

Indigenous Peoples can connect with their regionally nominated representative through the portal's regional pages. These pages also provide Indigenous Peoples organizations a platform to exchange and showcase their work. Similarly, the portal also provides updated information about the Party representatives from the five UN regional groups.

During its 6<sup>th</sup> meeting, the FWG decided to have a standing agenda item in its future meetings to regularly address updates on new portal content and address any knowledge safeguard concerns.

## Actions:

- The secretariat provides a brief update on the resource exchange via the web portal since the FWG's 10th meeting in November 2023.
- The FWG discusses the revised Outreach and Dissemination Plan and decides on ways to further incorporate diverse communication channels and formats, promoting ethical and equitable engagement of cultural values, worldviews, and knowledge systems of Indigenous Peoples and local knowledge systems in the UNFCCC process.

## 5. Enhancing the Coherence of the Actions of the Local Communities and Indigenous Peoples Platform

COP 24 encouraged the FWG to collaborate with relevant bodies within and outside the Convention. This collaboration seeks to enhance the coherence of LCIPP actions under the Convention. Consequently, the FWG has dedicated an agenda item at every meeting to this goal. Under this item, dedicated small group discussions will be held to facilitate engagement among the LCIPP contributors.
