

**Co-Chairs' Summary Note of Decisions from the
11th Meeting of the Facilitative Working Group | 29 May - 1 June 2024**

Adopted on 1 June 2024

The Facilitative Working Group (FWG) of the Local Communities and Indigenous Peoples Platform (LCIPP) operates based on consensus, per Decision 2/CP.24, paragraph 15.

At its 11th meeting, the FWG:

1. *Adopted* the agenda for the 11th meeting of the FWG.
2. *Expressed* appreciation for the leadership and dedication of the outgoing Co-Chairs, Ms. Gunn-Britt Retter and Ms. Tiana Carter and noted the changes to the membership and with thanks to the former members.
3. *Elected* Mr. Walter Gutierrez and Ms. Cathryn Eatock as their Co-Chairs, Dr. Agrafena Kotova, and Dr. Graeme Reed as their Vice Co-Chairs from FWG 11 until FWG 13.
4. *Noted* the intersessional changes made to the outlines and key considerations of the FWG report and the draft LCIPP workplan adopted at FWG 10.¹
5. *Requested* activity co-leads to incorporate insights from small group discussions in their respective efforts to complete the implementation of the activities under the LCIPP workplan for 2022-2024 and *agreed* to make informal summaries available.
6. *Reaffirmed* its commitment to collaborate with relevant constituted bodies and work programmes under the UNFCCC process that could include the global stocktake (GST), the global goal on adaptation (GGA), the mitigation work programme (MWP), the just transition work programme (JTWP), and the Least Developed Expert Group (LEG), in a manner that is strategically aligned with the FWG's mandate and vision, and the LCIPP workplan, taking into account the capacity of the FWG as supported by the Secretariat.
7. *Acknowledged* the contributions from the relevant entities outside the Convention, including but not limited to the Intergovernmental Panel on Climate Change (IPCC), the Intergovernmental Platform on Biodiversity and Ecosystem Services (IPBES) and Global Environment Outlook 7 (GEO 7), and *welcomed* continued collaborative opportunities in a manner that's strategically aligned with the FWG's mandate and vision, and the LCIPP workplan, taking into account the capacity of the FWG as supported by the Secretariat.
8. *Further recommitted* to develop common messages to be used in the FWG's engagement with relevant constituted bodies and work programmes under and outside the UNFCCC process, drawing from existing materials including but not limited to the FWG's reports, the FWG's vision statement, and LCIPP activity outputs and informal summaries, as appropriate.
9. *Agreed* to further explore strategic agenda design and additional participatory and innovative approaches, such as a poster/gallery format and enhanced intervention opportunities, to promote interregional and intergenerational exchanges and awareness-raising, with a view to ensuring FWG meetings advance the FWG's mandate and are relevant

to LCIPP contributors.

10. *Decided* to explore concrete ways to ensure a seamless transition to the proposed LCIPP workplan for 2025-2027 and facilitate the transition of institutional knowledge to new FWG members appointed for terms starting in May/June 2025.
11. *Agreed* to convene regular intersessional virtual meetings to facilitate the timely and effective implementation of the LCIPP workplan for 2022-2024, including by advancing decision points 5-11 above.
12. *Decided* to convene its 12th meeting from 5 to 8 November 2024, in conjunction with the 61st session of the Subsidiary Bodies and the 29th session of the COP.
