

Paris Agreement

Indigenous Peoples Platform (LCIPP) for the exchange of experiences and sharing of best practices on mitigation and adaptation in a holistic and integrated manner

(Decision 1/CP.21)







KNOWLEDGE

Promote the exchange of experience and best practices to apply, strengthen, protect and preserve traditional knowledge, knowledge of indigenous peoples and local knowledge systems to address and respond to climate change, taking into account free, prior and informed consent

CAPACITY FOR ENGAGEMENT

Build capacity of indigenous peoples and local communities to engage in the UNFCCC process and capacity of Parties to engage with the platform and with indigenous peoples and local communities

This includes providing guidelines for the ethical and equitable utilization of these resources. Additionally, the FWG welcomes submissions in various formats such as written case studies, short videos, photo narratives, and voice recordings. All submissions should adhere to the substantive and procedural elements of the right to free, prior, and informed consent from the holders of the knowledge shared. This call for submissions is part of the implementation of LCIPP's second three-year workplan.
