III. Annotations

Opening invocation

A knowledge holder or group of knowledge holders opens the 15th meeting of the Facilitative Working Group (FWG) of the Local Communities and Indigenous Peoples Platform (LCIPP) with an invocation or ceremony grounded in diversity of values, worldviews, and knowledge systems. This invocation helps participants ground themselves, listen with care, and recognize one another, creating an inclusive space that honors the interdependence of all beings, and lays a foundation of mutual respect, clarity, and shared intent.

1. Opening of the meeting

The 15th meeting of the FWG will open on 2 June 2026 at 14:00 CEST. The FWG Co-Chairs will invite the following:

Action:

The FWG will be invited to adopt the provisional agenda either as presented or with revisions, based on a consensus among its members, per decision 2/CP.24.

b. Election of FWG Co-Chairs and Vice Co-Chairs

Pursuant to COP decision 2/CP.24, the FWG will elect two Co-Chairs and two Vice Co-Chairs for a one-year term each, with one Co-Chair and one Vice Co-Chair being a representative from a Party and the other Co-Chair and Vice Co-Chair being a representative from Indigenous Peoples and, as appropriate, local communities.

Action

The FWG will be invited to elect its Co-Chairs and Vice Co-Chairs.

3. FWG membership

a. Membership changes and acknowledgment of alternates

COP 24 established the FWG of the LCIPP and decided that “the FWG shall comprise 14 representatives, as follows:

- a. One representative of a Party from each of the five United Nations regional groups;³
- b. One representative of a Party from a small island developing State;
- c. One representative of a least developed country Party;
- d. Seven representatives from Indigenous Peoples organizations, one from each of the seven United Nations Indigenous sociocultural regions.”

COP 24 further decided that Party representatives shall be appointed by their respective regional groups and constituencies and that the Chair of the SBSTA shall be notified of these appointments. COP 24 also decided that Indigenous Peoples representatives shall be appointed by the Indigenous Peoples, through their focal points, and that the Chair of the SBSTA shall be notified of these appointments.

Chairs and coordinators of United Nations regional groups and focal points of the IPO constituency transmit nominations or changes to their representation in the FWG in writing to the secretariat. For detailed information on the UNFCCC electoral process, please visit [here](#).

b. Staggered FWG membership

Recognizing the importance of institutional knowledge and continuity in the efforts of the FWG to further operationalize the LCIPP and facilitate implementation of the functions of the Platform, COP 29 decided that, among the representatives appointed as FWG members for terms beginning in June 2025, three Party representatives and three representatives from Indigenous Peoples organizations shall serve for a term of two years instead of three years. Thereafter, all representatives shall serve three-year terms, in accordance with decision 2/CP.24.

COP 29 also invited the FWG to decide which Party representatives and which representatives from Indigenous Peoples organizations shall serve for a term of two years, as referred to in paragraph 13 of decision 14/CP.29, in a manner that ensures geographical and gender balance.

At its 14th meeting, the FWG decided,² in line with decision 14/CP.29, paragraphs 13 and 14, the following:

- a. The representative from the Western Europe and Others Group (WEOG) will serve a term of two years instead of three.
- b. Two additional representatives of the Parties and three representatives of the Indigenous Peoples organizations will be identified ahead of FWG 15 to serve a term of two years.

Party representatives on the FWG from Small Island Developing States and the UN regional group of Africa expressed willingness to serve a two-year term instead of three to facilitate institutional knowledge and continuity. They further clarified that they would need to consult their respective Party groups to make any decision.

Representatives of Indigenous Peoples organizations on the FWG, from the United Nations Indigenous sociocultural regions of Africa, Asia and North America also expressed their willingness to serve a term of two years instead of three.

Action:

The FWG will be invited to decide which Party representatives and which representatives from Indigenous Peoples Organizations will serve for a term of two years, in accordance with decisions 14/CP.29 and 2/CP.24.

4. Progress on the implementation of FWG 14 decisions

At its 14th meeting, the FWG adopted nine decisions, including the adoption of the LCIPP core principles and a decision on the dates of its 15th meeting.³ The FWG also agreed on a set of intersessional actions. Under this agenda item, the FWG will share progress made in implementing these decisions, which will help inform discussions under other relevant agenda items, including agenda items 5 and 6.

- a. *Convening a virtual FWG meeting on coordination of Collective Approach 5 of the Baku Workplan in December 2025 to discuss approaches to implementing deliverable 5.5*

On 16 December 2025, the FWG held a virtual meeting to coordinate the implementation of Collective Approach 5 of the Baku Workplan. The FWG reviewed the mandated deliverables, including the development of a draft ethics protocol before its 15th meeting. The FWG further noted that the draft ethics protocol, along with recommendations and guidance on good practices, will ensure the ethical and equitable engagement, protection and use of traditional knowledge, the knowledge of Indigenous Peoples and local knowledge systems, as set out under CA5. It will be developed with the direct involvement of Indigenous Peoples and local communities and used at gatherings of knowledge holders, regional (or biregional) gatherings and seventh-generation round tables. The FWG also agreed to organize three workshops, each with two sessions, held in the morning and late afternoon CEST, to accommodate participants across time zones. The workshops were held between January and March 2026. More detailed discussions on the implementation of Collective Approach 5 of the Baku Workplan will take place under agenda item 5(e).

b. Allocating time at the 2026 LCIPP annual priority-setting meeting to discuss FWG 14 decision 6(a) and 6(b)

In light of military escalation in some parts of the world and related travel disruptions, the FWG decided to convene the 2026 LCIPP priority-setting meeting virtually to ensure the safety and security of all members and support their equitable participation. The meeting was held from 23 to 26 March 2026.⁴

At its 14th meeting in Belém, the FWG decided to allocate time at the 2026 LCIPP annual priority-setting meeting to discuss agreed upon topics, including but not limited to:

- a. Explore the possibility for recommendations related to the scope and functions of the FWG, in the context of its review in 2027;
- b. Assess and explore ways to enhance the engagement of local communities in the LCIPP work, taking into account outputs from the FWG 14 discussions; further notes, consistent with its mandate in decision 14/CP.29, para 15, that the FWG has already undertaken concrete steps to strengthen the engagement of local communities, alongside Indigenous Peoples, including through convening small-group discussions, inviting opening remarks, and engaging local knowledge holders/ practitioners from local communities in mandated LCIPP events.

Consistent with decision 14/CP.29, paragraph 15, the FWG noted steps already taken to strengthen the engagement of local communities, alongside Indigenous Peoples. These include adapting its biannual meetings to include small-group discussions, inviting opening remarks from local communities, and engaging local knowledge holders and practitioners from local communities in mandated LCIPP events.

At the 2026 LCIPP priority-setting meeting, the FWG took note of the challenge and recommendation reflected in its 2024 report.⁵ It also recalled the relevant COP 29 mandate and discussed existing pathways to enhance the engagement of local communities across the UNFCCC process, including mandated LCIPP events and the work of technical expert groups and working groups of constituted bodies, such as the non-economic losses expert group and the NAP Taskforce.

c. Taking LCIPP contributors' input into consideration in the implementation of the Baku Workplan for 2025–2027

The FWG took into consideration inputs from LCIPP contributors, as appropriate, in the implementation of the Baku Workplan of the LCIPP. This included the direct involvement of Indigenous Peoples and local communities in preparing the draft ethics protocol and in selecting 2026 LCIPP annual theme(s), which will be discussed in more details under agenda item 5 below.

5. Advancing the work under the Collective Approaches of the Baku Workplan of the LCIPP

COP 29 decided to continue the mandate of the FWG and welcomed the Baku Workplan of the LCIPP. Under this agenda item, the FWG will take stock of progress since FWG 14 and further advance implementation of the Collective Approaches under the Baku Workplan, individually and collectively, including through the active engagement of LCIPP contributors.

FWG 13 adopted an “activity co-lead” modality for implementing the six Collective Approaches. In line with its working modalities, FWG members may rotate the activities they

co-lead to broaden engagement, strengthen collaboration, and share accountability for the workplan's overall implementation. Annex I sets out the current and new co-leads for the Collective Approaches.

6. Strategic planning for the development of the FWG report and the next work plan of the LCIPP

Pursuant to decision 14/CP.29, COP 29 requested the FWG to report on the outcomes of its work, including the activities under the Baku Workplan, to consider and, as appropriate, propose recommendations relating to the scope and functions of the Platform and to prepare

a draft workplan for the LCIPP for 2028–2031 for consideration by the COP 32 through SBSTA 66.

The FWG requested the secretariat to circulate the preliminary outline for the FWG report and the draft elements of the LCIPP workplan (2028-2031), as discussed at the 2026 LCIPP priority-setting meeting, for consideration and adoption by the FWG at its 15th meeting.

COP 29 also invited Parties, Indigenous Peoples, local communities and stakeholders to submit via the submission portal by 30 September 2026 views on activities and thematic focuses for the workplan of the LCIPP for 2028–2031 for consideration by the FWG 16, to be held in 2026, and to submit, via the submission portal by 1 November 2026, views on the impact of work under the LCIPP, which will serve as input to the review of the Facilitative Working Group in 2027

At the 2026 LCIPP priority-setting meeting, FWG members were invited to mobilize regional engagement and responses to these calls for submissions through their respective regional networks and upcoming events, including mandated LCIPP events.

7. Strategic collaborations with relevant bodies and processes within and beyond the UNFCCC

In accordance with decision 2/CP.24, the FWG was encouraged to collaborate with other bodies under and outside the Convention. In this context, the FWG has included a dedicated agenda item in its biannual meetings to engage with relevant bodies and processes within and beyond the UNFCCC.

At its 15th meeting, the FWG will focus on collective stewardship of oceans and forests, and on the ethical and equitable application of diverse worldviews and knowledge systems to regenerate the health of all ecosystems for the benefit of all.

To facilitate this exchange, the FWG has invited experts on work related to the ocean under the UNFCCC process,⁷ and Research and Systematic Observation (RSO).⁸ The FWG has also invited representatives from Tropical Forest Forever Facility (TFFF) and the Intergovernmental Panel on Climate Change (IPCC).

Action

The FWG will be invited to identify concrete opportunities for collaboration with relevant bodies and processes to strengthen the ethical and equitable inclusion of Indigenous worldviews and knowledge systems and local knowledge systems in work related to oceans, forests and the health of all ecosystems.

8. Preparations for SB 64

a. Mandated LCIPP activities at SB64

Activity 5.2 of the Baku Workplan is an annual dialogue for Indigenous Peoples, local communities and Parties to promote the ethical and equitable engagement of values and knowledge systems of Indigenous Peoples and local knowledge systems in the design and implementation of NAPs, NDCs and national communications.

The FWG will convene this annual dialogue during SB64, on 10 June, from 13:00 to 15:00 CEST in Bonn.

COP 24 decided that the FWG will meet twice per year in conjunction with the sessions of the subsidiary bodies and the session of the COP.

Action

The FWG will be invited to consider possible dates of its 16th meeting in conjunction with COP 31.

b. Review and adoption of FWG 15 decisions

With support from the secretariat, the FWG Co-Chairs will present a draft summary note containing decisions from FWG 15. The draft will be circulated to FWG members for review in advance.

Action

The FWG will be invited to adopt the draft decisions from its 15th meeting as presented, or as revised based on consensus.

Annex III. Functions of the LCIPP, as per decision 2/CP.23

(a) Knowledge: the Platform should promote the exchange of experience and best practices with a view to applying, strengthening, protecting and preserving traditional knowledge, knowledge of Indigenous Peoples and local knowledge systems, as well as technologies, practices and efforts of local communities and Indigenous Peoples related to addressing and responding to climate change, taking into account the free, prior and informed consent of the holders of such knowledge, innovations and practices;

(b) Capacity for engagement: the Platform should build the capacity of Indigenous Peoples and local communities to enable their engagement in the UNFCCC process and the capacity of Parties and other relevant stakeholders to engage with the Platform and with local communities and Indigenous Peoples, including in the context of the implementation of the Paris Agreement and other climate change related processes;

(c) Climate change policies and actions: the Platform should facilitate the integration of diverse knowledge systems, practices and innovations in designing and implementing international and national actions, programmes and policies in a manner that respects and promotes the rights and interests of local communities and Indigenous Peoples. The Platform should also facilitate the undertaking of stronger and more ambitious climate action by Indigenous Peoples and local communities that could contribute to the achievement of the NDCs of the Parties concerned.
